The Florida Supreme Court has approved the language saying that Amendment 2 concerns the "single subject" of marriage. It simply takes the existing state marriage law and places it into the constitution, with similar effect. See Opinion to the Attorney General, 926 So. 2d. 1229 (2006). Most amendments do something new. Amendment 2 does nothing new but simply protects something timeless, longstanding and beautiful.

In Massachusetts and now in California, activist judges have ignored the will of the people and re-written marriage laws to legalize same-sex marriages. In the next six months, four of the seven members of the Florida Supreme Court will be replaced by Governor Charlie Crist. This will completely change the make up of the Florida high court. What happened in California could easily happen here in Florida over the next year. Amendment 2 protects the definition of marriage from activist judges.
